- There is ABSOLUTELY NO vendor parking around the perimeter of Washington Park. This parking is reserved for our Farmer’s Market attendees. Please Park in the surrounding neighborhood. It is detrimental to our market traffic when vendors decide to be lazy and not follow this rule. There is a substantial deficit in the amount of customers we receive, when they can’t find a place to park. The only exception made will be for those who have a disability tag/sticker on their vehicle. As always, talk to the market manager. If you break this rule regularly, you will not be allowed to continue your participation. **PLEASE INITIAL HERE** _____
